### **Customer Profile**

The Adult Detention Center of the Fred Allenbrand Criminal Justice Complex, located in New Century, Kansas, is a minimum security jail for Johnson County, Kansas and surrounding cities. The complex was completed in 1998 as an addition to the Johnson County jail located in Olathe, approximately seven miles away.

# **Application**

The Adult Detention Center has 11 air handler units that provide heat, ventilation and air conditioning throughout the building. The large fans on the air handlers are powered by Baldor electric motors that operate at over 1,700 rpm.

# Challenge

The commercial grade grease they were using to lubricate the bearings on the fan shafts would not stay in place, causing the bearings to be noisy and fail prematurely. In one particular unit, according to Gregg Quackenbush, maintenance mechanic, he would grease the noisy bearing which would quiet it down for a short time and then it would become noisy again overnight. "Quack" as he's called by his teammates, would grease the bearing daily only to have it noisy again the next day. He said you'd be able to hear it from the floor below.
