United Paper Converting located in Miami, Florida, is a subsidiary of Pedro Ramirez Paper Agency, Inc. This facility is dedicated to the converting of paper and paperboard for the printing industry.

#### **Application**

The manufacturing plant incorporates a 109" Cameron brand slitter/rewinder with shear cut blades that can rewind jumbo rolls while making longitudinal slits so as to produce the desired roll widths. United Paper also has one Maxon 67" sheeter and a Hamblet 73" sheeter as well as Polar brand guillotine trimmers. The guillotine trimmers feeds sheeted paper upon an air cushioned table for final uniform trimming of all four sides of the sheet and final placement on skids or in boxes. The plant also uses four Clark 10,000 lb forklifts and a Quincy 10 hp air compressor.

#### Challenge


